

CHECK LIST
INSTRUCTIONS TO OCCUPANTS REGARDING FUMIGATION

___ Provide key(s) to our Inspector prior to the date of the fumigation. If this cannot be done, then be present when our Fumigator arrives. However, the Fumigator will probably not arrive before the crew has completed the tent, at which time, occupants must be outside the premises. The Fumigator is required to have access to all areas of the structure. Outside doors will be locked by the Fumigator before the fumigation period commences.

REMOVE FROM THE STRUCTURE PRIOR TO OUR ARRIVAL:

- _____ All food, feed, drugs and medicinals (including those items in refrigerators and freezers). However, these items may be sealed in 4 milliliter (or greater) polyethylene plastic bags. Food and drugs in sealed glass or metal containers may remain in the house, except that high protein flour and cereals must be removed from the structure.
- _____ Plant Life.
- _____ Pets: Dogs, cats, birds, fish and all living animals.
- _____ Mattresses and pillows having waterproof covers, such as for baby cribs and sickrooms.
- _____ Easily removable valuables such as jewelry, money and negotiable securities. This protects you and us in case of third party intrusion. Only the Fumigator enters the premises.
- _____ We extinguish all pilot lights (hot water heaters, ranges, ovens, broilers, gas refrigerators, etc.)
- _____ Arrange with gas company for gas to be shut off at the meter prior to our arrival and opened again after the fumigation operation. Gas companies do not permit us to do this for you.
- _____ Please open all interior doors, cabinets and drawers some 4 inches. Raise all blinds and open all draperies. Open windows in each room 3 inches, as well as remove attic covers and any sub-floor trap doors.

The fumigation period is the time that fumigant remains in the structure. This is calculated by the Fumigator according to instructions and by instrumentation provided by the manufacturer of the fumigant. The time will vary according to conditions which are obtained at the specific time of fumigation.

AFTER THE FUMIGATION IS COMPLETE

Enter the premises no earlier than the date and time indicated on our NOTICE placed on your exterior doors. Our fumigator will have tested and found the premises totally safe for re-occupancy.

WHEN YOU HAVE FOLLOWED THE ABOVE INSTRUCTIONS, no contents of the structure will have been adversely affected by the fumigant which leaves no residual.

- Clothing and linens do not need to be washed or cleaned.
- Dishes and utensils do not need to be washed.
- Toys do not need to be cleaned.
- Bedding can be used immediately.
- Appliances can be used immediately.
- There will be no odor in the structure from the fumigant.
